

**MICRO-TAIN F.C.** is a high-powered cleaner designed specifically for floor surface maintenance utilizing Microfiber absorbent pads or cloths. The non-streaking **MICRO-TAIN F.C.** enhances the pad/cloth's soil pick-up, soil entrapment and allows for eventual release when desired by laundering. **MICRO-TAIN F.C.** may be safely used on the following flooring surfaces including hardwoods, engineered hardwoods, laminates, resilient tiles, vinyl, Luxury Vinyl Tile (LVT) (Karndean), ceramics, smooth natural stone, porcelains and marble.

#### DIRECTIONS:

Heavily soiled flooring should be cleaned by a conventional cleaning operation prior to maintenance with **MICRO-TAIN F.C.**. Lightly soiled floors should be cleaned using a microfiber dust mop. Consult your **GMP** Representative for specific recommendations based on you floors and equipment.

For all flooring surfaces listed above other than laminates, lightly spray a mist of **MICRO-TAIN F.C.** on the floor surface allowing for reachable coverage with the equipment you are using. Spray **MICRO-TAIN F.C.** behind you so that you are not walking over a wet surface. Use microfibered pad to glide over the sprayed area to pick up soil and evenly distribute the solution. Spray the next area to be cleaned and continue until the entire floor surface has been covered.

For laminate flooring, lightly prespray the microfiber pad or cloth to avoid the possibility of wetting the particle substrate of the laminate which might swell the floor. Reapply as necessary.
